Adult 7-day, combo, and permanent tee time only memberships are the only types valid for a permanent tee time.

Memberships are specific to the 18-hole course only. They are not valid on the Par 3 when the 18-hole course is closed. 18-hole members must either purchase a Par 3 add-on membership or pay the appropriate greens fees to play the Par 3 course.
